## **PARENTS/STUDENTS**

### **WELCOME CLASS OF 2012 AND UPPERCLASSMEN**

**Routes and Pickup times will be established one week prior to orientation; you will be notified of your pick up time and location by phone the weekend before orientation.**

#### **DO NOT MAIL THIS FORM !!**

You *must* bring your contract in with your deposit during schedule pick-up in late July. The exact date has not yet been established. You will be notified of exact dates later. This information will also be available on the school, website (cbhs.net). Mrs. Zagorski will be there to take your contract and answer any questions you have at that time. ***Please bring in your information on time, we are unable to change routes at orientation. For ANY STUDENT: If we do not receive the enclosed agreement from you, we will assume that you have found an alternate means of transportation and will not be taking the school bus. Routes are altered yearly to accommodate the contracts received. Do NOT assume that the route will be the same as the previous year.***

### **ACTIVITIES BUS INFORMATION**

The activities bus (late route) will leave *no later* than 7:00 PM. If your game, meeting, practice or activity will be later than 7:00 PM you must provide your own transportation home.

We are offering this transportation information to new students to perhaps answer some questions in advance of the 2008-2009 school year.

- We offer student Benedictine bus tickets at the cost of \$3.75 per one way trip. If you are buying single ride tickets, we will require a deposit of \$75.00 for 20 tickets along with the enclosed agreement when you pick up your son's schedule in late July. You will receive your tickets or pass at that time. You will be notified of your pick-up time/location the weekend before school begins.
- We also offer a bus pass at the cost of \$300.00 per quarter, which you may renew each quarter. If you wish to pay for your bus pass for the entire school year you may do so at a cost of \$1200.00. If you choose to pay quarterly, your deposit of \$300.00 along with the enclosed agreement is due when you pick up your son's schedule in late July. You will receive your tickets or pass at that time. You will be notified of your pick-up time/location the weekend before school begins.
- Benedictine bus tickets and RTA discounted tickets will be sold and distributed in the cafeteria during lunch periods.
- You must present a student ticket or quarterly pass to ride the bus. **THERE ARE NO EXCEPTIONS!**

OPTIONS: ***Please circle option selected (1, 2, or 3)***

1. Parent/Guardian will provide for Student's transportation both morning and afternoon. (We will not need Benedictine Transportation.)
2. Parent/Guardian will provide student's transportation one way. We will need Benedictine Transportation. Please specify whether you need Benedictine Transportation morning or afternoon ( \_\_\_\_\_ ). We will purchase single ride tickets at a cost of \$3.75 per ticket. A deposit of \$75.00 is required.
3. I wish to purchase a quarterly pass at the cost of \$300.00 which is renewable each quarter. This pass is good for morning, afternoon and after school activity bus. Payment is due with signed contract at the schedule pick-up late July.

Having selected an option, the following conditions are hereby agreed to:

- ◆ For option 3 Benedictine Transportation Dept agrees to provide transportation for the undersigned student from a designated stop to and from school each scheduled day. Parent/Guardian agrees to pay Benedictine High School for the service selected.
- ◆ This agreement will be in effect for the 2008-2009 school year.
- ◆ This agreement will be terminated if the student fails to adhere to the safety and or courtesy rules set by the Transportation committee of Benedictine High School. Any violations of these rules (back of page) will result in detentions, and/or suspension of riding privileges.
- ◆ No refunds or transferring of funds will be made on advance payments.
- ◆ This agreement must be signed and returned with deposit to Mrs. Zagorski during the schedule pick-up in July.
